No horse may be left unattended while hitched.

No horse may be tied to anything while hitched.

Removal of bridle while horse/pony is hitched will result in elimination and ejection from the grounds.

From Points South:

Route 95 North to

Exit 54B, Rt 133 W / E Main St toward Georgetown for 2.3 miles

At the **light** in G'town Center - landmark – Mobile Station

Turn RIGHT onto NORTH ST.; follow 1.0 miles

End at **214 North St** on your Left

From Points North:

Route 95 South to

Exit 54, Rt 133 W / E Main St toward Georgetown for 2.3 miles

At the **light** in G'town Center - landmark – Mobile Station

Turn RIGHT onto NORTH ST.; follow 1.0 miles

End at **214 North St** on your Left

From Route 495:

At **Exit 43**, turn **RIGHT** onto Ramp (Mass. Ave. / N. Andover) - 0.2 mile

Keep RIGHT to stay on Ramp (Mass. Ave. / N. Andover) - < 0.1 mile

Keep STRAIGHT onto Massachusetts Ave - 1.1 miles

Turn LEFT (North) onto SR-125 [SR-133] - 2.0 miles

Bear RIGHT (East) onto Local road(s) - 0.1 mile

Keep STRAIGHT onto SR-133 [Great Pond Rd] - 6.9 miles

Turn LEFT (North) onto SR-133 [SR-97] 0.1 mile

Keep STRAIGHT onto North St 1.0 mile

End at **214 North St** on your Left
